



School Fees 2020

Dear Families,

You have chosen a Catholic education for your child/ren at St Anthony's Parish Primary School. To allow us to continue to provide the high standard of education expected from parish schools, families accept responsibility to pay their fair share of school fees in a timely manner on enrolment. Thank you for providing financial support through payment of school fees which enables St Anthony's Parish Primary to provide a quality Catholic Education for your child/ren. After careful consideration, the school board has approved the 2020 School Fee Schedule. This includes the ACT Primary Tuition Fee and Catholic Schools Building Fund Fee set by the Catholic Education Commission.

Parents/Guardians who are responsible for paying school fees will be liable for school fees up until the end of term. Should payment in full not be possible at the time of leaving, a prior arrangement for payment will need to be made with the Principal or Finance Officer. If students are away from the school for extended periods (e.g. overseas holiday), full fees are payable for that time.

BUILDING FUND CONTRIBUTION – tax deductible

Per family per term \$178.00

The Building Fund is a fully tax deductible contributions payable by the eldest child at a systemic school. Funds raised by the building fund pay for all maintenance and upkeep for the school.

Please note that Marist, St Edmund's and Daramalan are NOT systemic schools.

If you wish to not contribute to the Building Fund, an email is required at the beginning of each year, requesting to opt out. Please email Katie.akers@cg.catholic.edu.au This is a yearly requirement.

SCHOOL FEES AND LEVY INCREASES

St Anthony's school board has now considered the school budget and approved no increases to any school based fee levies in 2020

Catholic Education Office Tuition fee and the Catholic Schools Building Fund contributions have increased in line with the Archdiocese of Canberra/Goulburn Catholic Education Commission decisions made in response to Australian and ACT Government education funding levels.

PAYMENT OF FEES OWING

Invoices for school fees and levies emailed to families by week 2 of each school term. Payments are required by the end of week 5 each term.

You are welcome to pay by cash, credit card, EFTPOS, direct debit, Qkr! App and Bpay (please see the bottom of your school fee statement for correct biller code and family reference number)

Families are invited to make an appointment to speak with the Principal or Finance Officer if fees cannot be paid on time, or if families are experiencing financial difficulty, please contact our Finance Office to apply for a Fee Remission or concession. Applications for fee concession will go to the sub Finance Committee for consideration and approval. It is important to note that all information is strictly confidential;

If no payments are received, a letter is sent from the Finance Committee requesting immediate payment; once again, parents are invited to contact the Principal or Finance Officer to request or discuss any of the above options;

If the second letter is ignored, the matter may be referred to our Debt Collection Agency for recovery procedures; and the Catholic Education Office is notified of all matters referred to the Debt Collection Agency.

If families are experiencing difficulties in meeting the required payment of school fees and levies, the sub finance Committee has a fees remission policy in place. Please contact Katie in the front office for more information.

We sincerely thank families for their efforts and the sacrifices needed to support Catholic Education at St Anthony's financially. This is for information only and is not intended to offend.

Find a table below outlining school fees for 2020. Reminder that if you have a current direct debit or paying by instalments via Bpay as there has been an increase to the CEO Tuition fees these payments may not cover the school fees for 2020. It is family's responsibility to ensure that all payment/instalment meet the requirements for 2020 fees.
